1. 3. The application for the Administration Charge (as defined in the ARIO) is hereby adjourned to May 9, 2023 at 2:00 PM.
4. The deposit paid by MAR ONE Aviation, L.L.C. (the "Purchaser") pursuant to the share purchase agreement dated April 23, 2023 between Thomas Jackson and the Petitioners, as vendors, and the Purchaser, as purchaser, as approved by the Court in the Order granted in these CCAA Proceedings on April 24, 2023, to 0854271 B.C. Ltd. to be forwarded to the Monitor, shall be paid to the Monitor on or before May 9, 2023.
5. Endorsement of this Order by counsel appearing on this application except for counsel to the Petitioners is hereby dispensed with.
