ON THE APPLICATION of the Petitioners coming on for hearing at Vancouver, British Columbia, on the 9th day of May, 2023; AND ON HEARING Christopher J. Ramsay and Nick Carlson, counsel for the Petitioners, and Vicki Tickle, counsel for Helo Investments Ltd. ("Helo"), and those other counsel listed on Schedule "A" hereto; AND UPON READING the material filled, AND pursuant to the Companies' Creditors Arrangement Act, R.S.C. 1985 c. C-36 as amended (the "CCAA"), and the inherent jurisdiction of this Honourable Court;

THIS COURT ORDERS AND DECLARES THAT:

- 1. Any individual, firm, corporation, governmental body or agency, or any other entities (all of the foregoing, collectively being "Persons" and each being a "Person") who has removed property (the "Returned Property"), regardless of any entitlements, ownership, or other interests therein, from the possession and/or control of the Petitioners on or after April 13, 2023, including the property taken from the address of Canwest Aerospace Inc., being Hangar #12, Unit 200, 5225 216th Street, Langley, British Columbia (the "Langley Premises"), and including any signage referring to either or both of Canwest Aerospace Inc. and Can West Global Airparts Inc., removed from the Langley Premises, shall be returned forthwith to the Petitioners, and in the case of such signage (other than decals), shall be reinstalled at the Langley Premises, all at the cost of the returning Person.
- 2. The Petitioners shall hold, keep safe and secure, and take no action or steps with respect to the Returned Property (other than relocating the Returned Property to other premises leased by the Petitioners) pending resolution of any dispute with respect thereto.
- 3. Any video taken on the Langley Premises by any Person between April 13, 2023 and the date hereof, including the video taken by Kendall Ballantine on May 6, 2023, and including any security video recorded on the Langley Premises between April 13, 2023 and the date hereof, shall be produced to the Monitor.
- 4. Endorsement of this Order by counsel appearing, other than counsel for the Petitioners and counsel for Helo, on this application is hereby dispensed with.
