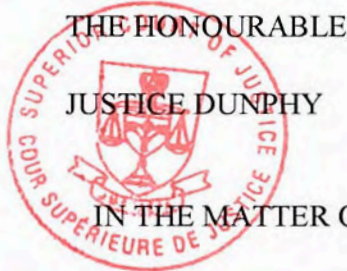

SURRENDERED LEASES ORDER

THIS MOTION, made by Dundee Oil and Gas Limited (“**DOGL**”) on its behalf and as general partner on behalf of Dundee Energy Limited Partnership (“**DELP**”) and together with DOGL, the “**Debtors**”) for an order directing each applicable Land Registry Office and/or Land Titles Office to delete and discharge certain instruments from title to the applicable properties, as more particularly set out below, was heard this day at 361 University Avenue, Toronto, Ontario.

ON READING the seventh report (the “**Seventh Report**”) of FTI Consulting Canada Inc., in its capacity as the Court-appointed monitor (the “**Monitor**”) and on hearing the submissions of counsel for the Monitor and the Debtors, National Bank of Canada, Lagasco Inc. (the “**Buyer**”), Ministry of Natural Resources and Forestry, no one appearing for any other person on the service list, although properly served as appears from the affidavit of Rachel Bengino sworn on November 13, 2018, filed:

8. **THIS COURT HEREBY REQUESTS** the aid and recognition of any court, tribunal, regulatory or administrative body having jurisdiction in Canada or in the United States to give effect to this Order and to assist the Debtors and the Monitor in carrying out the terms of this Order. All courts, tribunals, regulatory and administrative bodies are hereby respectfully requested to make such orders and to provide such assistance to the Debtors and the Monitor as may be necessary or desirable to give effect to this Order or to assist the Debtors and the Monitor in carrying out the terms of this Order.
