THE STEEL COMPANY OF CANADA, LIMITED, a company incorporated in Canada by letters patent granted by the Secretary of State of Canada on the 8th day of June, 1910 and having its head office at the City of Hamilton in the Province of Ontario, herein acting and represented by W.C. Chick and J.W. Younger,

Secretary, respectively, duly authorized for the purposes hereof as they declare;

DOMINION FOUNDRIES AND STEEL, LIMITED, a company incorporated in Canada by letters patent granted by the Secretary of State of Canada on the 18th day of May, 1917 and having its head office at the City of Hamilton in the Province of Ontario, herein acting and represented by J. Plumpton and Thomas Van Zuiden,

Treasurer, respectively, duly authorized for the purposes hereof as they declare;

HER MAJESTY THE QUEEN in right of CANADA represented by the NATIONAL HARBOURS BOARD, a body corporate and agent of Her Majesty under and by virtue of the National Harbours Board Act, having a place of business in the City of Sept-Iles and its head office at the City of Ottawa in the Province of Ontario, duly acting as authorized by Order in Council No. P.C. 1977-3428 dated the 6<sup>th</sup> day of DECEMBER, 1977, copy of which remains annexed to the present agreement after having been signed for identification by P.J. Cloutier, General Manager of the Port of Sept-Iles herein representing the National Harbours Board, as duly authorized by a resolution of the said Board dated the 6<sup>th</sup> day of DECEMBER, 1977, a certified copy of which remains annexed to the present agreement after having been signed for identification by the said P.J. Cloutier;

hereinafter called the "PURCHASER".

WHEREAS the Vendors, which word in this Agreement includes any of them, and the Purchaser are part owners of Block Z in the Township of Arnaud, in the Registry Division of Sept-Iles, in the Municipality of the City of Sept-Iles;

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the mutual covenants herein contained, and upon the terms and conditions hereinafter set out, the parties hereto agree as follows:

1. The Vendors shall not sell or transfer any part of said Block Z to a third party except in accordance with the terms of paragraph 2 hereof it being understood that a third party shall not include any of the Vendors or any subsidiary, associated or affiliated company of any of the Vendors;
2. If the Vendors shall desire to sell or transfer any part of Block Z to a third party, then the said Vendors shall first give the Purchaser an opportunity to purchase the said part of Block Z at the Vendors' price. The Vendors shall notify the Purchaser in writing of the price and

terms upon which they are willing to sell and the Purchaser shall have 120 days from the date such notice is received to agree to purchase the said part of Block Z. In the event that the Purchaser shall fail to offer to purchase the said part of Block Z, then the Vendors may sell the said part of Block Z to a third party on the same terms and conditions as they were offered to the Purchaser. If the Vendors arrange a sale on terms different as to price or any other matter from those offered to the Purchaser, then the Purchaser shall be given 120 days to purchase the said part of Block Z on the new terms; otherwise the sale of the said part of Block Z may be completed to the third party on the new terms.

3. This agreement shall enure to the benefit of and be binding upon the heirs, executors, administrators, successors and assigns of each of the parties hereto.

LIMITED signed at Cleveland, Ohio, one of the United States of America on the 29th day of November, 1977; the representatives of THE STEEL COMPANY OF CANADA, LIMITED signed at Toronto, Ontario, on the 1st day of December, 1977; the representatives of DOMINION FOUNDRIES AND STEEL, LIMITED signed at Hamilton, Ontario, on the 1st day of December, 1977; and the representative of the NATIONAL HARBOURS BOARD signed at MONTREAL, in the Province of QUEBEC, on the 7th day of DECEMBER, 1977.

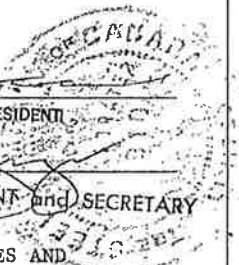

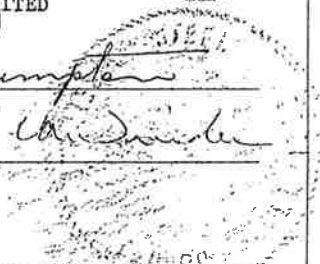

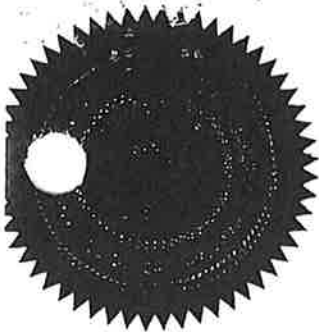
