Mr Justice Hamilton,

We have received yesterday with great disbelief, together with all the parties on the Service List, a stamped copy of the motion for a bankruptcy order, which was apparently presented secretly and on an *ex parte* basis before the Registrar who approved on January 13, 2016 its filing and the opening of a bankruptcy file, even before you heard the Motion seeking the temporary lift of the stay for that very same purpose.

We consider that in doing so Groupe Unnu-EBC s.e.n.c. and EBC Inc. (UNNU/EBC) clearly acted in violation of the stay of proceedings in the present matter.

We have requested clarifications from counsel for UNNU/EBC and strongly advised them to agree to a Consent Order to annul and quash the filing of their Motion for a bankruptcy order and the opening of a bankruptcy file. You will find below our exchanges. UNNU/EBC has since served an Amended Motion for the purpose of seeking leave to lift the stay on a *nunc pro tunc* basis.

We understand that counsel for the CCAA Parties will bring a Motion to quash this decision of the Registrar, to annul the opening of a bankruptcy against The Bloom Lake Iron Ore Mine Limited Partnership and any other appropriate remedy in the circumstances against UNNU/EBC and their counsel.
