**ORDER**

---

[1] **THE COURT**, upon reading the Bloom Lake CCAA Parties' *Motion for the Issuance of an Order Declaring that the Stay Period Applies in respect of Certain Proceedings* (the "**Motion**"), having examined the affidavit and the exhibits;

[2] **CONSIDERING** the report of the Monitor dated <\*>, 2015;

[3] **CONSIDERING** the provisions of the *Companies' Creditors Arrangement Act*;

**FOR THESE REASONS, THE COURT HEREBY:**

[4] **GRANTS** the present Motion;

[5] **DECLARES** that the stay of proceedings (the "**Stay**") ordered in respect of the Bloom Lake CCAA Parties pursuant to the Initial Order dated January 27, 2015 (as subsequently amended, rectified and/or restated) applies to the complaint for wrongful termination filed by Mr. Sylvain Lemonde against the Petitioner Cliffs Québec Iron Mining ULC with the Québec *Commission de norms du travail* (the "**Lemonde Complaint**") and to the proceedings before the Québec *Commission des relations du travail* in relation to this complaint in the file bearing numbers CM-2015-2016 and 62-00-71719 (the "**Commission Proceedings**");

[6] **STAYS** the Lemonde Complaint and the Commission Proceedings until the termination of the Stay or any extension thereof as may be ordered by this Court, subject to further order of this Court;

[7] **ORDERS** the provisional execution of this Order notwithstanding any appeal and without the necessity of furnishing any security;

[8] **WITHOUT COSTS**, save in the case of contestation.
