Claim for OPEBs (Post-employment benefits). Mr. Chaulk been employed in Scully since May 13rd 1981. He was injured at work in or around July 1988. He has been on Newfoundland's Workers compensation since that day, as he was permanently unable to work. Under the insurance agreement, Mr. Chaulk is entitled to maintain insurance coverage and employment relationship with Wabush Mines while he continued to receive Workers compensation. Mr. Chaulk had to retire at the age of 65, as per the terms of the Workplace, Health, Safety and Compensation Act. At the date of retirement, his insurance coverage was to be automatically converted to post-employment Life and Health insurance, just like all other OPEBs beneficiaries. Therefore, his claim should be treated as all the other OPEBs claims were. Claim amount was calculated by Segal using the same methodology.

As a result of having attained your Normal Retirement Date on December 1, 2016 the Plan requires that you commence receipt of your monthly pension benefit; and therefore we are providing you with a **Retirement Statement** which you must review and sign in order to proceed. In addition to your **Retirement Statement**, your package includes additional documentation which may be required to be completed depending on your personal circumstances and the pension option you elect. Please refer to the attached "Checklist" for assistance in ensuring you have completed all the required documentation in order to receive your monthly pension benefit from the Plan.

Please note that amounts detailed in this **Retirement Statement** are in respect of your Defined Benefit ("DB") entitlement only. If you have an account in the Defined Contribution ("DC") Provision administered by Sun Life Financial, you will receive communication directly from Sun Life Financial.

We further note that the receipt of pension payments may affect your eligibility for Employment Insurance ("EI") payments. We recommend that you check your personal situation with EI representatives before making a pension election.

As you are aware, the Plan is being wound-up effective December 16, 2015. Once the Federal and Newfoundland and Labrador regulators approve the wind up, all Plan members' pension entitlements will be settled. If you choose to start pension payments now, you will also need to elect how you would like your pension plan benefit to be settled on approval of the Plan wind up. You may elect either a) or b) below:

- a) **Annuity Purchase Option:** continue to receive a monthly pension payable from one or more insurance companies. The amount payable will be adjusted for the final funded percentage of the Plan at the date of settlement, or
- b) **Transfer Option:** receive a one-time lump sum transfer of the commuted value of your pension benefit (adjusted for the final funded percentage of the Plan at the date of settlement) to a locked-in financial retirement account (part of it may be paid in cash). Any pension payments received prior to the settlement date will reduce the commuted value.
