NOTICE OF OBJECTION BY HER MAJESTY THE QUEEN IN RIGHT OF NEWFOUNLAND AND LABRADOR, AS REPRESENTED BY THE MINISTER OF NATURAL RESOURCES, TO THE MOTION FOR THE ISSUANCE OF AN APPROVAL AND VESTING ORDER WITH RESPECT TO THE SALE OF CERTAIN ASSETS AND AN ASSIGNMENT ORDER WITH RESPECT TO THE ASSIGNMENT OF CERTAIN CONTRACTS

(Sections 11 and 23(k) of the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36)

TO THE HONOURABLE MR. JUSTICE STEPHEN W. HAMILTON, J.S.C., HER MAJESTY THE QUEEN IN RIGHT OF NEWFOUNLAND AND LABRADOR, AS REPRESENTED BY THE MINISTER OF NATURAL RESOURCES DESIRES TO ADVISE THIS COURT AS FOLLOWS:

- 1. On June 13, 2017, the attorneys for the petitioners Wabush Iron Co. Limited, Wabush Resources Inc. and Wabush Lake Railway Company Limited filed a Motion for the issuance of an approval and vesting order with respect to the sale of certain assets and an assignment order with respect to the assignment of certain contracts (the "Motion").
- 2. By this Motion, the Wabush CCAA Parties seek this Honourable Court's approval of an Asset Purchase Agreement dated June 2, 2017, for the sale of what has been referred to as the Wabush Mine (the "APA").
- 3. The APA lists several "Purchaser's Conditions" and "Vendors' Conditions" at Articles 8.1 and 8.2. These sections both provide that on or before the "Replacement Financial Assurance Condition Date" being June 16, 2017 the Purchaser and the Government of Newfoundland and Labrador, Department of Natural Resources shall have agreed as to an amount of Replacement Financial Assurance, and that the Purchaser shall have provided acceptable evidence of such an agreement to the Vendors.
- 4. Furthermore, the Purchaser has represented and warranted at Article 4.1(8) that it has sufficient financial resources or has arranged sufficient financing for it to



- procure Replacement Financial Assurance acceptable to the Government of Newfoundland and Labrador, Department of Natural Resources.
- 5. By this Motion, the Government of Newfoundland and Labrador, Department of Natural Resources, wishes to advise this Honourable Court and the parties to the present proceedings that, at this time, the Purchaser has not yet succeeded at procuring sufficient Replacement Financial Assurance, and has not yet arrived at an agreement with the Government of Newfoundland and Labrador, Department of Natural Resources.
- 6. The Government of Newfoundland reserves its right to raise grounds of objection when the Motion is presented on June 26, 2017.
