**ORDER TEMPORARILY LIFTING THE STAY OF PROCEEDINGS**

(Section 11.02 of the *Companies' Creditors Arrangement Act*)

- [1] **ON READING** the Creditor / Petitioner's Motion entitled *Requête de la créancière AIA Automation inc., pour lever temporairement la suspension des procédures* brought pursuant to Section 11.02 of the *Companies' Creditors Arrangement Act* (the "**CCA**"), corresponding to entry number 112 on the Court record print-out (the "**Motion**"), the affidavit and the exhibits in support thereof;
- [2] **CONSIDERING** the Motion, the affidavit and exhibits in support thereof;
- [3] **CONSIDERING** the absence of contestation by either the Petitioners / Respondents or the Monitor;
- [4] **CONSIDERING** paragraph 56 of the Order issued by the Honourable Justice Martin Castonguay, J.S.C. on January 27, 2015, as amended on February 20 and April 17, 2015 (the "**Initial Order**");

**WHEREFORE THE COURT:**

- [5] **GRANTS** the Creditor / Petitioner's Motion entitled *Requête de la créancière AIA Automation inc., pour lever temporairement la suspension des procédures*;
- [6] **LIFTS** the stay of proceedings provided for in the Initial Order, for the sole purpose of allowing the service and registration of a prior notice of exercise of a hypothecary right in respect of the legal hypothec registered in the Land Registry for the Cadastral Division of Saguenay under number 21 308 964;
- [7] **THE WHOLE** without costs.
