- 1. On April 23, 2024, the Court of King's Bench of Alberta granted order declaring EES Equipment Inc. bankrupt.
- 2. The Company liquidated all of its assets in 2021. Accordingly, there were no assets available for the Trustee to realize on.
- 3. National Bank guaranteed total of \$17,500 for the three EES bankruptcy estates, \$6,000 was transferred to EES Lands Inc. estate, and \$5,000 was transferred to 1780932 Alberta Ltd. estate, with \$6,500 remaining with EES Equipment Inc. estate to administer bankruptcy.
- 4. The Trustee has included a summary of its fees incurred in the administration of the bankruptcy proceedings, including prepaid services for Ascend license fee, advertisement for first meeting of creditors, miscellaneous notice mailing expense and court fee, along with this final statement of receipts and disbursements.
