AFFIDAVIT OF C. HADDON MURRAY
(Sworn May 18, 2016)
(Re Assignment of Contracts)

I, C. Haddon Murray, of the City of Toronto, in the Province of Ontario, MAKE
OATH AND SAY:

1. I am an associate at Stikeman Elliott LLP, counsel to FirstOnSite G.P. Inc. ("**FirstOnSite GP**") and FirstOnSite Restoration L.P. ("**FirstOnSite LP**") and together with FirstOnSite GP, ("**FirstOnSite**"), a limited partnership formed under the laws of Ontario. Hereinafter, where reference is made to the FirstOnSite enterprise as a whole, the term FirstOnSite will be used. As such, I have knowledge of the matters to which I hereinafter depose, except where otherwise stated. I have spoken with certain of the directors, officers and/or employees of FirstOnSite, as necessary, and where I have relied upon such information do verily believe such information to be true.
2. This affidavit is sworn in support of the motion brought by FirstOnSite seeking an order (the "**Assignment Order**") assigning certain contracts from FirstOnSite to the Purchaser (as defined below).
3. This affidavit is supplemental to the affidavits of Kevin McElcheran sworn April 26, 2016, May 5, 2106 (the "**May 5 Affidavit**") and May 12, 2016 (the "**May 12 Affidavit**") and the affidavit of Adam Zalev sworn April 26, 2016.

4. Capitalized terms not defined herein have the meaning set out in the May 12 Affidavit.

A. Status of the Assignment of Contracts

5. Details of FirstOnSite's process and efforts to obtain consents for the assignment of Consent Required Contracts are set out in the May 12 Affidavit at paragraphs 8 to 26.

6. As a result of discussions with the Purchaser and the Monitor, the total number of Consent Required Contracts, including Essential Contracts, has been reduced to approximately 76 contracts with 56 counterparties. Attached as **Exhibit "A"** is a list of the Consent Required Contracts (which is to be included as Appendix 6 to the Sale Agreement), not including the 14 Essential Contracts.

7. In the May 5 Affidavit at paragraph 15, Kevin McElcheran stated that:

FirstOnSite has sent letters to the counterparties of the Consent Required Contracts requesting their consent to an assignment to the Purchaser and advising the counterparties that, if they do not consent to the assignment, FirstOnSite will seek a court order in respect of the same.

Since that time the Purchaser has added additional contracts to the Consent Required Contracts list. Letters were sent to the counterparties of those additional contracts requesting their consent to the assignment of their contracts and advising that, absent their consent, FirstOnSite would seek a court order approving such assignment.


8. As at May 17, 2016, FirstOnSite has obtained consents for assignment from 35 counterparties to 40 of the Consent Required Contracts. Consents for assignment from 21 counterparties in respect of 36 Consent Required Contracts remain outstanding.

9. A schedule listing the Consent Required Contracts for which consents remain outstanding (the "**Outstanding CR Contracts**") is attached as Schedule "A" to the draft Assignment Order. FirstOnSite or its advisors have been in email or telephone contact with representatives of each of the counterparties to the Outstanding CR Contracts.




