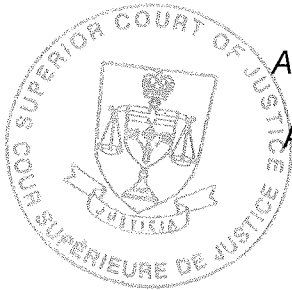

ORDER
(Lifting Stay)

THIS MOTION, made by Christopher Fowler, for an Order lifting the stay of the within proceedings against Indalex Limited ("Indalex") pursuant to paragraph 15 of the Amended and Restated Initial Order dated April 8, 2009 and paragraph 2 (under the heading Stay Extension) of the Order (Stay Extension) dated May 4, 2010, was read this day at Toronto, Ontario;

WHEREAS Christopher Fowler acknowledges that his claims are claims arising out of events which occurred prior to the issuing of the Initial Order in the within proceedings on April 3, 2009;

AND WHEREAS Christopher Fowler intends to limit his claims arising in the action commenced by Christopher Fowler as against Indalex et al, as Court File No. 08-01864, to any available insurance that will respond to his claims;

1. THIS COURT ORDERS AND DECLARES that the stay of proceedings against Indalex is hereby lifted and does not operate in respect of the continuance of the action commenced by Christopher Fowler against Indalex in Ontario Superior Court of Justice Court File No. 08-01864; provided however that Christopher Fowler's recovery from the action shall be limited to any available insurance and no payment or distribution shall be made by Indalex.

2. THIS COURT ORDERS AND DECLARES THAT Indalex shall not be obligated to incur further cost or take any action defending or responding to the personal injury action in Court File No. 08-01864
