breach of rule 1.09 of the Rules of Civil Procedure.

Nonetheless, given the shortage of time, the Minister uploaded Mr. Jaafari's materials onto Caselines.

After I released the two signed orders on November 3, 2022 Mr. Jaafari again improperly wrote to the Court. This time Mr. Jaafari wrote to me via my assistant.

I referenced this in my November 14, 2022 Endorsement - noting that it was improper (see para 85 footnote #2)

Since the release of my Endorsement Mr. Jaafari continues to write directly to the Court via Justice Koehnen and my assistant in violation of Rule 1.09.

I am therefore ordering that Mr. Jaafari immediately cease

and desist from corresponding with any judge of this Court or their assistant

If Mr Taabari wishes to liaise with the Court he must follow the proper procedure.

If Mr Taabari wishes to schedule a case conference he can contact Manitar's counsel Ms. Rebecca Kennedy and obtain a hearing date agreeable to the Applicants and other stakeholders.

Thereafter, Mr Taabari or others, can obtain a date with the Commercial List Office via email - MAG.CSD.To.SCICom@ontario.ca.

To be clear however, Mr Taabari shall no longer forward emails or other correspondence to Superior Court judges, their assistants, or
