Pursuant to an Order of the Honourable Mr. Justice Morawetz of the Ontario Superior Court of Justice (Commercial List) (the "Court") dated March 31, 2011, FTI Consulting Canada Inc. was appointed as the monitor (the "Monitor") of Priszm Income Fund, Priszm Canadian Operating Trust, Priszm Inc. and Kit Finance Inc. (collectively, the "CCAA Applicants", and together with Priszm LP (the "Vendor"), the "Priszm Entities").

Pursuant to an Order of the Court dated September 14, 2011, the Court approved the asset purchase agreement dated July 29, 2011, as amended (the "FMI Agreement #1") between the Vendor, Priszm Inc., FMI Atlantic Inc., as purchaser (the "Purchaser"), and FMI Ontario Inc., as guarantor (the "Guarantor"), and provided for the vesting in the Purchaser of the Vendor's right, title and interest in and to the Purchased Assets (as defined in the FMI Agreement #1), effective upon the filing of a Monitor's certificate with the Court (the "Monitor's Certificate #1").
- C. Pursuant to an Order of the Court dated September 14, 2011, the Court approved the asset purchase agreement dated August 23, 2011 (the "FMI Agreement #2") between the Vendor, Priszm Inc., the Purchaser and the Guarantor, and provided for the vesting in the Purchaser of the Vendor's right, title and interest in and to the Purchased Assets (as defined in the FMI Agreement #2), effective upon the filing of a Monitor's certificate with the Court (the "Monitor's Certificate #2", and together with the Monitor's Certificate #1, the "Monitor's Certificates").
- D. Pursuant to an Order of the Court dated September 14, 2011, the Court provided for, *inter alia*, the termination of the proceedings of the CCAA Applicants under the *Companies'* Creditors Arrangement Act, R.S.C. 1985, c. C-36, as amended, effective at 12:01 a.m. on the business day after the Monitor's filing with the Court of the Monitor's Certificates.
- E. Pursuant to an Order of the Court dated September 14, 2011, the Court provided for, *inter alia*, the appointment of RSM Richter Inc. ("**RSM Richter**") as receiver (the "**Receiver**") of the assets, undertakings and properties of the Priszm Entities, effective at 12:01 a.m. on the business

day after the filing of a certificate by RSM Richter certifying that the Monitor's Certificates have been filed with the Court.
