THIS COURT ORDERS that:

1. The stay of proceedings provided for in the Initial Order pronounced on October 11, 2018 (the "Initial Order"), as extended by the Orders pronounced November 2, 2018 and December 12, 2018, is hereby extended to April 15, 2019.

2. The Administration Charge (as defined in paragraph 31 of the Initial Order) is hereby increased to a maximum aggregate amount of \$450,000.

3. Effective as of the date this Order, Purewal Farms Partnership is hereby added as a Petitioner to these proceedings.

4. Effective as of the date of this Order, the Initial Order hereby applies to Purewal Farms Partnership. For greater certainty, Purewal Farms Partnership is a non-corporate entity to which the Initial Order applies in the same fashion as it applies to the corporate Petitioners.

5. The approval of counsel as to form listed as Schedule "A" hereto, except for counsel for the Petitioners, is dispensed with.
