NOTICE OF MOTION

TAKE NOTICE that an application will be made by the Petitioners in these proceedings (collectively, "Trident") before the Honourable Madam Justice Romaine, in Chambers, at the Calgary Courts Center, 601 - 5th Street SW, in the City of Calgary, Province of Alberta on Friday, the 15th day of January, 2010 at 9:30 in the forenoon or so soon thereafter as counsel may be heard, for the following relief:

- 1. declaring service of notice of this application and the supporting materials to be good and sufficient, and abridging the time therefor, if necessary;
- 2. extending the Stay Period (as such term is defined in the Amended and Restated Initial Order) in these proceedings to May 6, 2010;
- 3. scheduling a Joint Cross-Border hearing to occur on or before February 17, 2010, or such other date as may be agreed between the Court in these proceedings and the U.S. Bankruptcy Court in the Chapter 11 Cases relating to these proceedings;
- 4. approving the Amended Cross-Border Protocol in the form attached as Exhibit "A" to the Affidavit of Todd Dillabough, dated January 12, 2010;
- 5. seeking an Order sealing Exhibit "A" to the Affidavit of Neil Augustine, dated January 12, 2010, and sealing the Supplement to the Fourth Report of the Monitor, dated December 21, 2009, including the Nexen Agreement attached thereto; and
- 6. granting such further and other relief as counsel may advise and this Honourable Court deems just.

AND FURTHER TAKE NOTICE that the grounds for this application are as follows:

- 1. An extension of the Stay Period to May 6, 2010 is necessary to allow for the anticipated restructuring of Trident, and is otherwise appropriate in the circumstances.
- 2. Trident continues to have strong financial and operational performance. Trident continues to have discussions with its stakeholders concerning sponsorship of a restructuring plan.
- 3. Further to its efforts, Trident has received two Restructuring Proposals which, among other things, contemplate the full payout or re-financing of the obligations of TEC under the Second Lien Credit Agreement.
- 4. Trident believes that an immediate attempt at sale of the enterprise without adequate protections, including a stalking horse and bid protection, would cause a serious loss in value for some or all of its stakeholders and would seriously undermine Trident's restructuring efforts.
- 5. A Joint Cross-Border Hearing is required for Trident to: seek the approval of a commitment letter to establish a stalking horse and provide related bid protections, including break fees; establish a marketing process to determine if superior alternative transactions exist; establish the qualification of bidders.
- 6. Paragraph 15 of the original Cross-Border Protocol was informally objected to by the U.S. Trustee overseeing the U.S. Chapter 11 Cases. An Amended Cross-Border Protocol deleting paragraph 15 (and certain other conforming changes) was approved by the U.S. Bankruptcy Court on December 10, 2009 and requires the approval of this Honourable Court.
- 7. Paragraph 15 of the original Cross-Border Protocol set forth certain requirements for the U.S. Debtors to undertake in the Chapter 11 Cases. Given that these requirements did not affect these Canadian proceedings and that the major stakeholders have consented to the current amendment, Trident believes the Amended Cross-Border Protocol is appropriate for these proceedings and should accordingly be approved.

8. The Restructuring Proposals and the Supplement to the Fourth Report of the Monitor

contain commercially sensitive financial and other information, the release of which

would prejudice Trident and its stakeholders if it were to be made a part of the public

domain. Trident respectfully requests that these documents be sealed in order to comply

with the request of certain stakeholders, protect the commercial sensitivity of the contents

thereof, and preserve the integrity of potential processes that Trident may undertake in

the future in respect of it's restructuring.

9. Trident continues to work closely with the Monitor and all of Trident's stakeholders in all

respects, and the Monitor supports the proposed relief and stay extension; and

Trident has acted and continues to act in good faith and with diligence with respect to 10.
